HOUSEHOLD & LIVING ASSISTANCE – Animal/Pets, Appliances, Cleaning & Removalist Services, Furniture, Household Maintenance/Improvements, Insurance costs, IT equipment, Mobile Housing, Phones/phone cards, Renewable Energy Systems, Tools & Maintenance Equipment, Utility Bills, Vehicle costs and maintenance, Vehicle purchase/Vehicle loan
Items & services that are NOT covered under this category include: Cash payments to individuals for any service or item.
